Fee-Waived Community Partnership Program

Dear Community Partner:

Zeum is happy to offer limited, free admission vouchers to qualifying organizations. Vouchers will be distributed to those organizations that demonstrate need, admission tickets will be based on **organizational** budget size. Each organization may make a request only ONCE in the next year:

Org. Budget Size	Vouchers to be Offered Equivalent to...
\$1 million +	5 general admissions tickets <i>or</i> 5 Carousel tickets
\$500,000 - \$999,999	8 general admissions tickets <i>or</i> 8 Carousel tickets
\$250,000 - \$499,999	10 general admissions tickets <i>or</i> 10 Carousel tickets
\$100,000 - \$249,999	12 general admissions tickets <i>or</i> 12 Carousel tickets
Less than \$100K	15 general admissions tickets <i>or</i> 15 Carousel tickets

To be able to continue to offer assisted programs in the future, we request that **ALL** organizations who take advantage of this offering provide a letter of support that expresses the impact that accessing Zeum has meant for your group.

These letters help us secure funding for assisted programs and are crucial elements in our efforts to continue our services to organizations like yours.
